



# The 163<sup>rd</sup> Hospices de Beaune Wine Sale on 19 November to Offer 753 Barrels from all 51 Cuyées Produced from the 2023 Harvest

Sale of Unique 'Presidents' Barrel' of Mazis-Chambertin Grand Cru to Benefit the Fondation pour la Recherche Médicale (FRM) & the Initiative de Recherche pour une Longévité en Bonne Santé (IRLB)



PARIS & BEAUNE, 26 OCTOBER 2023 – The 163<sup>rd</sup> edition of the annual Hospices de Beaune wine sale on Sunday, 19 November will present a total of 51 different cuvées of the 2023 vintage produced from vineyards across the Hospices' 60-hectare holdings, now in its third and final year of organic conversion. These 51 cuvées will be divided into 753 lots: 574 barrels of red wines and 179 barrels of white wines. With the addition of the unique Presidents' Barrel and 16 barrels of eaux de vie, this year's sale comprises 770 barrels in total.

Sotheby's is working with the Hospices de Beaune, in preparation for the 163<sup>rd</sup> edition, for the third consecutive year. Funds raised from the sale will be used to finance major new structural projects in 2024. These include the construction of a new hospital building to replace the first building of the modern era which dates to 1971 (due to open in four years), the rebuilding of the hospital in Seurre, the renewal of hospital equipment with cutting edge technology, and a modernisation of the winery.

Earlier this year, the Hospices Civils de Beaune pledged its commitment to support the issue of healthy ageing, in response to a concern about this public health priority. The proceeds from the sale of the special Charity barrel, also known as the Pièce des Présidents (Presidents' Barrel), will be sold in aid of the Fondation pour la Recherche Médicale (FRM) and the Initiative de Recherche pour une Longévité en Bonne Santé (IRLB) – both of which are dedicated to maintaining life expectancy in good health for





all. Distinguishing this year's Charity barrel is not only the wine within - a Mazis-Chambertin Grand Cru - but also the material with which it was made: the wood of an oak tree used to restore the spire of Notre Dame in Paris.

After the devastating fire of Notre Dame in April 2019, the d'Harcourt family donated 10 prestigious trees for the restoration of the nave and spire of the cathedral from the Vibraye forest, their privately owned forest located in north-western France. Among these 220-year-old trees – the wood of which exactly matches the original source material used for Notre Dame – one fortuitously measured 19 meters, in excess of the 15.5 meters needed for the current restoration. Bernard d'Harcourt decided to donate this remaining volume of wood to the Hospices de Beaune specifically for the charity wine auction. The oak was entrusted to Barraud's cooperage, a small artisanal business located in Charente, which is celebrating its 40<sup>th</sup> year in the cooperage industry, for splitting into staves. The resulting staves were subsequently given to the Hospices de Beaune and the crafting of the barrel was carried out in the heart of Burgundy by Tonnellerie Cadus.

For the Presidents' Barrel – the star lot of the auction – the Hospices de Beaune has selected Mazis-Chambertin Grand Cru, Cuvée Madeleine Collignon, produced from the magnificent Grand Cru parcel which was donated to the Hospices in 1976 by Jean Collignon and named in memory of his mother. Dense, with silky, elegant tannins, the wine promises a guarantee of good longevity.

The full offering will be listed on sothebys.com (<a href="here">here</a>), where the auction will also be livestreamed at 2.30pm CET on 19 November.

Marie-Anne Ginoux, Managing Director, Sotheby's France, said: "This is our third year selling alongside the Hospices de Beaune and our team at Sotheby's is working with even greater passion and pride to contribute to the renewed success of this exceptional sale. The bar has been set very high with the record result of 2022, an exceptional total of €32m that testifies both to the excellent quality of the wines produced by Ludivine Griveau and her team and to the worldwide demand for high-quality Burgundy wines. For the past three years, the sale has been a clear priority for us. It is essential to support the Hospices Civils de Beaune, a cause that we in turn are privileged to support."

Guillaume Koch, Director and Chairman of the Board of Hospices Civils de Beaune, said: "Like the vast majority of French public hospitals, we are facing a number of challenges, including a shortage of medical and nursing staff, and outdated equipment and buildings. Previous sales, including the highly successful sale in 2022, have already enabled us to modernise the hospital, improve reception and working conditions and plan major investments. The new projects are major and structural. As with every year, the Hospices de Beaune is promoting a cause. This year it's about ageing well. Establishments such as ours are faced with an ageing population and an increasingly heavy burden of care for the elderly. Now more than ever, we need the continued generosity of our benefactors to help us improve the way we care for people, through better reception, more and better-staffed clinics and fundamental research."

**Ludivine Griveau, Manager of the Hospices de Beaune wine estate**, said: "The 60-hectare estate is now in its third and final year of organic conversion, with a view to obtaining the organic label for the Hospices de Beaune wines which will leave the winery in 2024. The 2023 harvest was meticulously





sorted both in the vineyards and in the winery to ensure that the quality of the grapes met the estate's high standards. The focus was firmly on quality rather than quantity. The whites reveal aromas of fresh white fruit, are each firmly rooted in their respective terroirs and are very powerful on the palate. Their texture reveals a fine balance with good acidity. The Pinot Noir grapes that arrived in the vats were superb and the result of a drastic selection process. They quickly released their intense ruby colours and aromas of fresh fruit. With gentle, gradual extractions over eighteen to twenty-five days, depending on the cuvée, the tannins are coated and smooth. The red wines are structured but not excessive. The finish is very fruity, with textures conducive to a fairly long ageing period."

All these vineyards come from bequests and donations, and their production is auctioned every year on the 3rd Sunday in November, as part of the world's most famous charity sale. Thanks to its heritage, this hospital plays a leading role in the two major activities of Beaune and its region: tourism and wine.

The auction, which can include more than 500 lots, is the most famous and oldest charity wine auction in the world (1859). True to its founding values, each year the Hospices de Beaune supports a charity by donating the profits from the sale of a piece of wine, known as the "Pièce du Président". Proceeds from the sale of this wine are ear-marked for the upkeep of the hospital's heritage and the modernisation of its equipment and buildings.
